### Nonfarm jobs grow by 4,000 in February; Unemployment rate at 3.8%

NOTE: February data will not reflect any impact from the COVID-19 pandemic.

WETHERSFIELD, March 26, 2020 – Preliminary Connecticut nonfarm job estimates from the business payroll survey administered by the US Bureau of Labor Statistics (BLS) show the state gained 4,000 net jobs (0.2%) in February 2020, to a level of 1,700,800 seasonally adjusted. Over the year, nonagricultural employment in the state grew by 13,300 (0.8%) seasonally adjusted. The January 2020 originally-released job gain of 2,600 was revised up to a gain of 3,300). The number of the state's unemployed residents was estimated at 72,600, seasonally adjusted, up 400 from the revised January 2020 level. As a result, Connecticut's February unemployment rate is at 3.8%, seasonally adjusted, up one-tenth of a percent from the revised January level. Resident employment estimates include the self-employed and residents working out of state and are determined separately from the nonfarm payroll job estimates above. None of the movements in payroll job estimates are considered statistically significant.

"February's payroll job numbers revealed a heathy increase of 4,000 jobs over January 2020," said Andy Condon, Director of the Office of Research at the Connecticut Department of Labor. "In addition this was the sixth month in a row of payroll job growth. Unfortunately, with the impact of the spread of the COVID-19 virus we can expect payroll jobs to decline as a result of sharply increased layoffs and furloughs."

#### Nonfarm Jobs Detail (business establishment survey)

**Private sector** employment grew by 3,300 (0.2%) to 1,463,00 jobs over the month in February, and are now up by 12,400 (0.9%) seasonally-adjusted jobs over February 2019. The **government** *supersector* rose by 700 jobs in February to a total of 237,500, and is up by 900 jobs (0.4%) over the year. Note that the growth in the government sector is largely due to the decennial census. The **government** *supersector* includes all federal, state and local employment, including public higher education and Native American casino employment located on tribal land.

Eight of the ten major industry supersectors gained employment in February, and two declined. The **leisure and hospitality** *supersector* (1.4%, 157,900) led gains, adding 2,200 net new jobs. **Education and health services** (0.5%, 345,100) was next with 1,800 new positions. **Manufacturing** (0.6%, 162,500) added 900 positions while the **government** *supersector* (0.3%, 237,500), grew by 700. **Other services** (0.9%, 65,000) contributed 600 net new jobs and **financial activities** (0.4%, 124,500) added 500. The **construction** *supersector* (0.5%, 60,300) posted 300 new jobs while the **information** *supersector* (0.3%, 31,500) added a net 100.

On the down side, **trade, transportation & utilities** (-0.8%, 294,500) led declines in February, dropping 2,300 positions while the **professional & business services** *supersector* (-0.4%, 221,400) was next, shedding 800 positions.

**Connecticut Labor Market Areas (LMAs)**: Two of the six *LMAs* seasonally adjusted by the Bureau of Labor Statistics saw job increases in February 2020, while three saw declines. The *Danbury LMA* (0.0%, 77,700) was unchanged. The *New Haven LMA* (0.6%, 294,400) led gains with an increase of 1,800 jobs while the *Hartford LMA* (0.2%, 589,400) grew by 1,300.

The *Bridgeport-Stamford-Norwalk LMA* (-0.3%, 406,800) led declines, losing 1,100 positions. The *Norwich-New London-Westerly RI LMA* (-0.2%, 129,700) and the *Waterbury LMA* (-0.3%, 68,500) both saw declines of 200 jobs.

Note: The six major Connecticut LMAs are estimated independently from the statewide data by the BLS and cover more than 90% of the nonfarm employment in the state. Thus, estimates will not fully sum to the statewide total.

Hours and Earnings: The private sector workweek, not seasonally adjusted, averaged 33.7 hours in February

2020, up five-tenths of an hour from the same month a year ago. Average hourly earnings at \$33.77, not seasonally adjusted, were up \$0.95 (2.9%) from the February 2019 estimate (\$32.82). The resultant average private sector weekly pay amounted to \$1,138.05, up \$48.43 from a year ago (4.4%). The 12-month percentage change in the Consumer Price Index for All Urban Consumers (CPI-U, U.S. City Average, not seasonally adjusted) in February 2020 was 2.3%. Information for the manufacturing production workweek and earnings can be found in the table section of this release under the "Hours and Earnings" data category. *Current all-employee private sector hours and earnings estimates can be volatile due to fluctuating sample responses.* 

#### Labor Force Data (residential household survey)

The February 2020 unemployment rate for Connecticut is estimated at **3.8%** (seasonally adjusted), up one-tenth of a point from the revised January 2020 figure and unchanged from a year ago when it was 3.8%. The US jobless rate in February 2020 was 3.5%, down three-tenths from February 2019.

Based on the Local Area Unemployment Statistics model (LAUS - a statistical model using the CPS – Current Population Survey residential data), the number of Connecticut unemployed residents, seasonally adjusted, was up 400 from January at 72,600. Over the year, the number of the state's jobless residents was up by 1,000 (1.4%). The state's labor force grew an estimated 1,200 over the month at 1,930,500, and is up over the year by 26,500.

February 2020 seasonally adjusted average weekly initial unemployment claims for first-time filers in Connecticut was 2,927, up from January by 73 claims and down by 58 claims (-1.9%) from the February 2019 level of 2,985.

The nonfarm employment estimate, derived from a survey of businesses, is a measure of jobs in the state; the unemployment rate and labor force estimates are based on a household survey, and measure the work status of people who live in Connecticut. Overall, as the national and state economies recover, volatility in monthly numbers can be expected. Job and employment estimates are best understood in the context of their movement over several months rather than observed changes in a single month's value.




