Nonfarm jobs grow sharply by 73,300 in June.

***NOTE:** Connecticut's official unemployment rate for June produced by the Bureau of Labor Statistics Local Area Unemployment Statistics program (LAUS) continues to be impacted by pandemic-related survey data problems. Data collection and misclassification issues in the Census Bureau's Current Population Survey, the foundation of the state's residential labor force statistics, caused residential unemployment to be significantly underestimated. Connecticut's official unemployment rate is not accurate (see below). The Bureau of Labor Statistics is actively working to overcome this problem as quickly as possible.

WETHERSFIELD, July 16, 2020 – Preliminary Connecticut nonfarm job estimates from the business payroll survey administered by the US Bureau of Labor Statistics (BLS) show the state gained 73,300 net jobs (5.1%) in June 2020, to a level of 1,509,900 seasonally adjusted. However, over the year, nonagricultural employment in the state fell by 172,700 (-10.3%) seasonally adjusted. The May 2020 job gain of 25,800 was revised up by 2,600 jobs. The change in payroll job estimates is considered statistically significant.

"Connecticut saw the largest single month gain in jobs on record in June," said Andy Condon, Director of the Office of Research at the Connecticut Department of Labor. "However, this gain has to be viewed from the perspective of the unprecedented job losses caused by the COVID-19 pandemic. The largest job gains in June were seen in those industries most impacted by pandemic closures – Leisure & Hospitality, Trade, and Education & Healthcare."

Nonfarm Jobs Detail (business establishment survey)

Private sector employment recovered by 68,200 (5.5%) to 1,297,200 jobs over the month in June and are now down by 150,800 (-10.4%) seasonally-adjusted jobs over June 2019. The **government supersector** grew by 5,100 jobs in June to a total of 212,700 and is down by 21,900 jobs (-9.3%) over the year. The **government supersector** includes all federal, state and local employment, including public education and Native American casino employment located on tribal land.

Eight of the ten major industry *supersectors* employment gains in June. Improving *supersectors* included:

- Leisure & Hospitality – (21,900 gained, 26.6% change, 104,300 total jobs)
- Trade, Transportation & Utilities – (19,100, 7.7%, 265,900)
- Education & Health – (16,300, 5.4%, 316,000)
- Other Services – (6,800, 14.9%, 52,300)
- Government – (5,100, 2.5%, 212,700)
- Construction & Mining – (2,800, 5.2%, 56,800)
- Manufacturing – (1,100, 0.7%, 154,300)
- Professional & Business services – (600, 0.3%, 200,900)

One *supersector* saw declines:

- Financial Activities – (-400, -0.3%, 118,300)

The Information *supersector* (28,400) was unchanged.

Connecticut Labor Market Areas (LMAs): All six **LMAs** seasonally adjusted by the Bureau of Labor Statistics saw employment gains in June 2020. The **Bridgeport - Stamford - Norwalk LMA** (5.2%, 348,600) led gains, adding 17,300 jobs. The **Hartford LMA** (2.5%, 526,900) grew by 12,900 net jobs, while the **New Haven** (4.9%, 263,000) added 12,200. The **Norwich - New London - Westerly LMA** (12.0%, 108,400) gained 11,600 positions while the **Danbury LMA** (7.0%, 70,300) grew by 4,600 positions. The **Waterbury LMA** (4.5%, 58,600) picked up 2,500 net jobs.

Note: The six major Connecticut LMAs are estimated independently from the statewide data by the BLS and cover more than 90% of the nonfarm employment in the state. Thus, estimates will not fully sum to the statewide total.

Hours and Earnings: The **private sector** workweek, not seasonally adjusted, averaged 34.6 hours in June 2020, up seven-tenths of an hour from the same month a year ago. Average hourly earnings at \$33.72, not seasonally adjusted, were up \$0.93 (2.8%) from the June 2019 estimate (\$32.79). The resultant average private sector weekly pay amounted to \$1,166.71, up \$55.13 from a year ago (5.0%). The 12-month percentage change in the Consumer Price Index for All Urban Consumers (CPI-U, U.S. City Average, not seasonally adjusted) in June 2020 was 0.6%. Information for the manufacturing production workweek and earnings can be found in the table section of this release under the “Hours and Earnings” data category. *Current all-employee private sector hours and earnings estimates can be volatile due to fluctuating sample responses.*

Labor Force Data (residential household survey)

The June 2020 official unemployment rate for Connecticut was estimated by the BLS Local Area Unemployment Statistics program (LAUS) to be 9.8% (seasonally adjusted). The US jobless rate in June 2020 was 11.1%, down 2.2 points from May.

The Connecticut unemployment rate continues to be underestimated due to challenges encountered in the collection of data for the June Current Population Survey (CPS) which is the foundation of the statistical model used to determine all states’ unemployment rates. In addition to a poor response rate in an already small sample size in Connecticut, key questions continue to be misinterpreted and misclassified. Specifically, a significant number of respondents who should have been classified as *temporarily out of work and therefore unemployed* were instead classified as *employed*, but away from work (e.g. sick). The Office of Research estimates the unemployment rate to be in the range of 16 - 17% for the Mid-June period (same time frame as the BLS estimate). We estimate that the employment rate declined from May. This estimate was made using Connecticut residential unemployment insurance claims and adding similar factor for the unemployed self-employed.

June 2020 seasonally adjusted average weekly initial unemployment claims for first-time filers in Connecticut was 9,986, down from May by 19,772 claims and up by 6,331 claims (173%) from the June 2019 level of 3,655.

*The nonfarm employment estimate, derived from a survey of businesses, is a measure of jobs in the state; the unemployment rate and labor force estimates are based on a household survey, and measure the work status of people who live in Connecticut. Overall, as the national and state economies recover, volatility in monthly numbers can be expected. **Job and employment estimates are best understood in the context of their movement over several months rather than observed changes in a single month’s value.***

Starting with March, 2011, our monthly statewide and major LMA nonfarm job estimates have been taken over by the US Department of Labor Bureau of Labor Statistics. This is the final phase of transition in this program, which began in 2008. As a result of changes in the estimation procedures, you are likely to see more variability in month-to-month estimates of job counts. Caution should be used in interpreting any single month's estimate. The data are best interpreted to identify trends and cycles over several months and quarters. 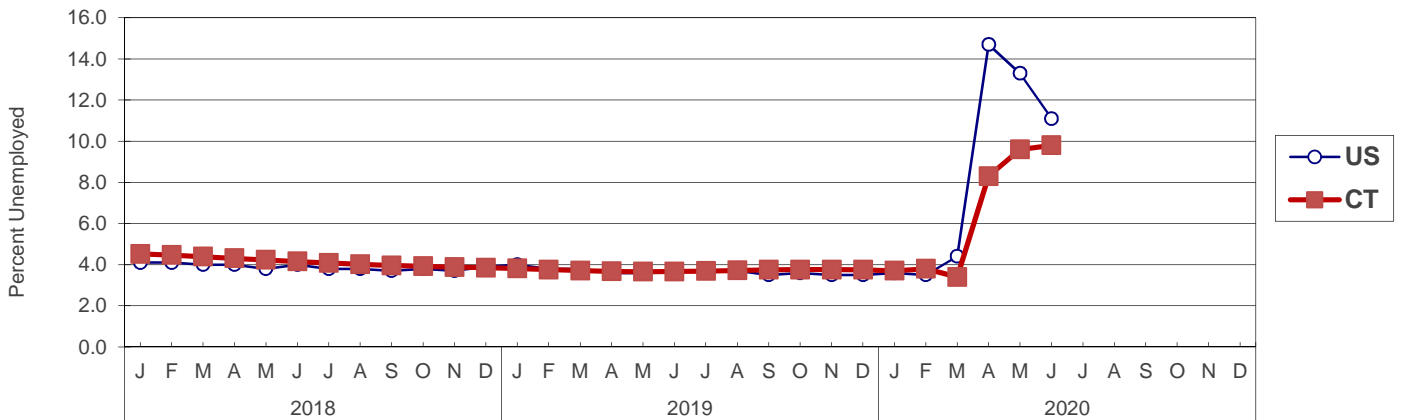

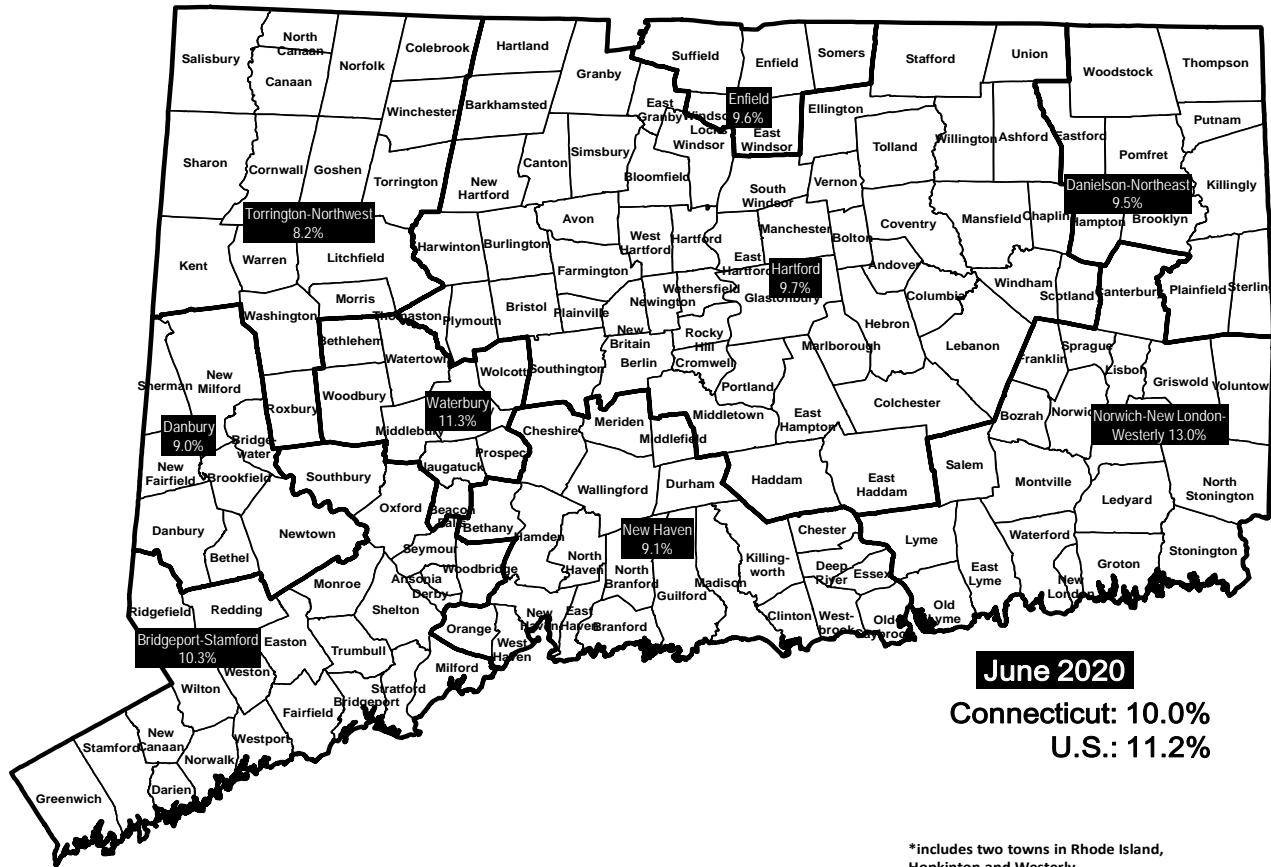
